- § KSA - Selkirk merger- KSA will be run as a separate entity until June 2006 when it will be integrated into Selkirk. KSA faculty were 100% in favour of the merger. There are questions into which union faculty will merge.
- § Caribou becomes a regional university with OLA merger
- § merger of UBC with Okanagan viewed as a hostile takeover by faculty
- § proposed name change for CIEA at AGM to Post Secondary Education Federation of BC
- § bargaining - common table being developed; some pessimism over gov't attitude towards bargaining - nine colleges will be involved
